ORDER:

The Commissioner of Horticulture, AP, Hyderabad vide reference 2^{nd} read above has requested the Govt. for issue of necessary orders on the subsidy pattern for the implementation of Micro Irrigation in Ananthapuramu District.

2. In pursuance of the announcement made by Hon'ble Chief Minister of Andhra Pradesh on 06-10-2014 in Ananthapuramu District and taking into consideration the proposals of the Commissioner of Horticulture, AP, Hyderabad in the reference 2nd read above, Govt. after careful examination and in partial modification of the orders issued in the reference 1st read above, hereby issue the following guidelines for the implementation of Micro Irrigation Programme in Ananthapuramu District:-

I. Eligibility of Farmers:

- a) All SC/ST Farmers under SF and MF category are eligible for 100% subsidy on the MI system unit cost, upto a maximum of Rs.1.00 Lakh per family, subject to a maximum of 5 acres, whichever is less.
- b) All Other Small and Marginal Farmers are eligible for 90% subsidy on the MI System unit cost, upto a maximum of Rs.1.00 Lakh, per family, subject to a maximum of 5 acres, whichever is less.
- c) Farmers with holdings up to 10 acres are eligible for 90% subsidy, upto a maximum of Rs.1.00 Lakh per family, subject to a maximum of 10 acres, whichever is less.
- d) Farmers with holdings above 10 acres are eligible for 50% subsidy, up to a maximum subsidy of Rs.1.00 lakh on MI system cost, per family, subject to a maximum of 12.5 acres, whichever is less.
- 3. In the selection of beneficiaries, not less than,
 - > 17.10% of the total financial target shall be covered by SC farmers under SF/MF category.
 - > 5.33% of the total financial target shall be covered by ST farmers under SF/MF category.

- > 58.57 % of the total financial target shall be covered by farmers with land holdings up to 10 acres.
- ➤ 19% of the total financial target shall be covered by other farmers holding above 10 acres.
- 4. The other guidelines issued vide G.O.Ms.No. 52, dt. 05-11-2014 of A&C (Horti) Department (reference 1^{st} read above), will continue without any modification and should be followed for the implementation of the Programme.
- 5. This order will come into force with immediate effect i.e. from the date of issue of this order.
- 6. The Commissioner of Horticulture, Andhra Pradesh, Hyderabad shall take further necessary action in the matter accordingly.
